## **What to Expect During the Admission Process at Rigel Recovery Residential Center**

Arrive at 28407 St. Rt. 7, Marietta, Ohio at your scheduled time.

Staff will complete an inventory of your belongings before assisting you in laundering your belongings. While your laundry is in process you will complete admission paperwork with a staff member.

## **Personal Items Allowed at Rigel Recovery Residential Center**

All clothing, including hats, coats, and gloves will be washed in hot water and dried at high heat at the time of admission. Bring only washable items. Shoes and boots must be washable or they will be chemically treated. RRRC cannot be responsible for any damage to these items.
